What is the purpose of this update?



Description of this fund

The Cash option invests 100% in cash and cash equivalents. It is constructed with a focus on there being a low risk of a member incurring a loss in any year. The option is expected to provide a return after tax and investment expenses broadly in line with the after-tax movement of the Bloomberg NZBond Bank Bill Index.

Example of how this applies to an investor


Mary had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Mary received a return after fund charges were deducted of \$519 (that is 5.19% of her initial \$10,000). Mary also paid \$0 in other charges. This gives Mary a total return after tax of \$371 for the year.


